Welcome and Approval of July 2020 General Parent Meeting Minutes

Annemarie Thornton called the meeting to order at 6:35 pm. Brian Heck moved to accept the June General Parent Meeting minutes; 2nd by Jenn Karpf. Motion carried. Minutes approved.

Mr. Santanello/Mr.Haddad

- Thanks to everyone for the involvement!
- Thanks for the flexibility with band camp given the weather situation.
- There is some concern for the school board decision that will happen on Thursday. A decision could be made to stop all fall activities on Thursday evenina.
- There have been requests for musicians' masks & bell covers to decrease the risk of spread of COVID. The cost is approximately \$1200. Request has gone to the principal for consideration for the school to pay for the equipment. However, the principal would like to hold until we see if the school board makes any changes to the ability for the band to continue the season.
- The band will be competing virtually with US Bands to decrease risk of students riding on buses. Taking all precautions to keep the students safe during practice. Marching band is different from other sports. This has all been communicated to the school board. It may be more effective if parents chose to send a letter to the school board in support of the band given all the safety precautions that are being taken. Mr. Santanello has written to all board members.
- The band is still not approved to be in groups larger than 35. There is a plan being worked on if this rule continues. There are options for small ensembles to compete with US Bands. Other schools are doing something similar to what we are doing.
- Question from parent on letting students in the school so there is rain cover. We need to make sure band season is going to continue before trying to work on this possibility.
