New Business

- Fridays there will be no rehearsals, but may be utilized for make-up rehearsals.
- Discussion about Champs Dinner, Hospitality Nights, Halloween Trunk or Treat, Community Night.
 - o The Executive Board would like separate committees to work out the details on how to do these events
 - Champs Dinner-typically held in cafeteria. It is unlikely that Champs Dinner being held indoors will be an option. Jenn Karpf found Camp America, a camp with a large pavilion that may work 10/24 or 25. It has parking, restrooms, a stage, and sound system. We would need to work out food and cost. Sunday 10/25 would provide an opportunity to hold Champs Dinner during daylight hours. Champs Dinner is an optional event typically held Saturday afternoon. Students would still be socially distanced with masks on. Mr. Santanello needs to discuss the event with school administration. Reach out to organizers with questions. Space will be limited for decorating purposes.
 - o Hospitality Night-typically held every Thursday night throughout the season for parents to watch rehearsals, socialize, and purchase Spiritwear. This year, the band will not be rehearsing together, however we are approved to host Hospitality Nights. No refreshment served. No Spiritwear sold. Basically an open rehearsal to take pictures and watch the band rehearse. Will expand if able in the future. Mr. Santanello will send out section locations ahead of Hospitality Night. Masks will be required.
 - Saturday Performances-parents can watch the band perform when own child is performing in order to keep crowd small. Limited to two guests. There are no chairs on the turf field. Bring a chair if needed. Masks required and social distancing. Performance times will be posted. Only performances open for Saturday viewing, not rehearsals. Guard at 6:00 p.m., Woodwinds at 7 p.m., Percussion at 6:30 p.m., and Brass at 7:30 p.m.
 - If coming to view either Hospitality Night or Saturday performance, please observe safety protocols. Do not come if having Covid symptoms.
 - Clearance Form is not necessary for parents viewing because they will not be near students.
 - Cheering is allowed.
 - This is subject to change.
 - Halloween Trunk or Treat Mr. Santanello will request approval from school administration for this event.
 - Cars will face each other in parking lot. Students staggered, parent hands out candy, wearing masks, gloves if needed.



- October 31 is a Saturday, would take place after performance.
- Trunks would be decorated
- Students will be able to wear costumes.
- As students perform, they can go through candy line which will help stagger them
- Each student has own bag, parent drops candy in bag
- There are 85 students
- Limited to band students (no siblings this year)
- The plan is to finish the day at 5p.m. to facilitate trick-or-treating
- o Community Night-Night to honor seniors. The community invited to come. More information to come.
- New Front Ensemble Sound System This non-budgeted purchase requires the approval of the General Membership present
 - Seeking to purchase a new sound system. Parts of system was last purchased 2013-2016 and are due for new equipment. Also running sound from back of field in addition to front this year so two systems are currently needed. This will also be a long-term investment. School district is paying for some components. NPMA asked to pay \$5500 for speakers.
 - Funds would come from: Directors Fund: \$1000, instrument replacement fund: \$3400, general budget: \$1100 to cover cost.
 - Renting is not feasible. Borrowing from school is not a long term. solution.
 - Used for both outdoor and indoor band
 - A new generator would be beneficial with a new soundsystem, but not required.
 - School board has approved the purchase of the other items
 - Annemarie Thornton asked for a motion to purchase a new front ensemble sound system not to exceed \$5500, coming from: \$1000 from the Director's Fund, \$3400 from Instrument Replacement Fund, \$1100 from General Fund. Kris Neild motion. Brian Heck second
 - 25 yes votes, 1 no vote. Motion passed
 - Mr. Santanello will send exact quote out to Executive Board tomorrow
